### **DEAN MANSHIP APPOINTED EMERGENCY PREPAREDNESS PROGRAM MANAGER**

**CLAREMONT, Calif.** — The appointment of **Dean Manship as Emergency Preparedness Program Manager** for Claremont University Consortium was announced today by Robert Walton, Chief Executive Officer, Claremont University Consortium (CUC).

Walton stated, “Dean Manship is well known in emergency management field in the 23 campus California State University System. He brings to CUC and The Claremont Colleges an exceptional depth of knowledge and experience in emergency management. While at California State University San Marcos (CSUSM) Dean developed a state of the art emergency management program, working closely with regional and state emergency officials. He holds a Certified Emergency Manager (CEM) certificate, which is the “gold star” certification in the emergency management field. Mr. Manship will assume an important role working with CUC and The Claremont College and our community in emergency preparedness.” Mr. Manship’s appointment begins October 2, 2010.

Dean Manship has served most recently as Emergency Manager for the Department of Emergency Management at CSUSM. While there he developed a state of the art, all-hazards emergency management program to protect the life safety, physical infrastructure and environment of CSUSM. His role required him to work closely with city and countywide emergency management agencies to coordinate preparedness activities and exercises with external response and support organizations. Prior to assuming emergency management responsibilities, Mr. Manship served as Director of Business Planning and Information Management at CSUSM. Mr. Manship holds a Certified Emergency Manager (C.E.M.) certification, is a certified emergency trainer and holds numerous FEMA emergency management institute certifications. In addition, Mr. Manship is a member of the Radio Amateur Civil Emergency Service (RACES) and Amateur Radio Emergency Service (ARES) groups that sponsor communication drills.

Mr. Manship holds a B.A. in Business Administration from California State University San Marcos and a M.B.A. from CSUSM.

Commenting on joining the CUC management group, Manship stated, “I look forward to working with CUC and The Claremont Colleges and partners in the community to move forward in emergency preparedness.”
